The 8th Call for Proposals on individual online consultancy was announced on February 2, 2022 with an application deadline on February 28, 2022.

Selection criteria

Criteria used to assess the quality of the applications:

Criteria / value	High	Medium	Low
Evidence of Demand	An application contains clear reference to the beneficiary in the programme country and its request for support.	Justification for the assignment is strong and follows from the development context description, however no specific reference to national beneficiary is provided.	No clear beneficiary can be identified.
Relevance of Russian expertise	An assignment would support sharing of Russian expertise and experience, includes a reference to Russian institutions or experts.	An assignment would benefit from international expertise, including Russian expertise.	Local expertise would be more appropriate for the assignment.
Complementarity to current portfolio / no duplication	An assignment is complimentary to current portfolio of UNDP projects, including projects funded by Russia, it supports new cooperation opportunities.	An assignment is complimentary to UNDP projects funded by Russia, however it cannot be said with certainty whether the assignment does not duplicate activities in other ongoing UNDP projects.	A risk exists that an assignment might duplicate activities already supported by Russia in ongoing UNDP projects.
