  - Anti-Corruption Champions video campaigns, including in <u>Ukraine</u>, Belarus, Kyrgyzstan;
  - Activities and awareness raising in 10 countries of the region.
  - ✓ Launch of the Transformative Governance and Finance Facility, in collaboration with K&I Cluster
    - Usage of court database for better predictability of the legal system (Armenia)
    - Improvement of communication between local and central levels of government (Serbia)
    - Participatory budgeting at the local level (Tajikistan)

#### ✓ Resource mobilization support

- Finalization of Sub-regional project on "Fostering Local Democracy" aims at strengthening participatory democracies and the EU integration process in the Western Balkans (WB) (EUR 8.5 million)
- Technical support to Albania, Kyrgyzstan, Turkey, Uzbekistan, Belarus to secure funds for local governance initiatives
- Open Data leading to resource mobilization at CO levels (Serbia, Uzbekistan, Albania)
- Second phase of the Romanian project as well as the European Commission support to the ACT network



Institutions and systems enabled to address awareness, prevention and enforcement of anti-corruption measured across sectors and stakeholders

- ✓ Regional Open Data Leaders' Network 8 participants from ECIS countries
- ✓ Data for Development Results Conference 120 participants
- ✓ Academia from 8 countries attend a 2 week training in Montenegro on data driven journalism
  - Curriculum in the process of being mainstreamed in 3 countries (Kyrgyzstan, Albania and Moldova)
- ✓ <u>Ministry of Data</u>, open data challenge, drew 40% more applications than in 2015



# Key priorities for 2017 Output 1

Institutions and systems enabled to address awareness, prevention and enforcement of anti-corruption measured across sectors and stakeholders

- ✓ Constructive dialogue between local governments and CSOs to ensure inclusive and transparent local development processes
- ✓ Promotion of new models of public service delivery mechanisms including government technology solutions to support efficient, transparent and clientoriented service delivery mechanisms
- ✓ Technical support to strengthen effective oversight over local budgets formulation and execution.
- ✓ Support implementation of political, innovative and solution driven initiatives in anti-corruption, local governance and open data, especially in areas pertaining to financial openness

- ✓ Promotion of inclusive political processes, with a special focus on strengthening parliamentary oversight and supporting new forms of engagement
- ✓ Support to regional dialogues on SDG coordination,/SDG 16 implementation and M&E support; SDG localization; policy and programmatic support to UNCTs and UNDP COs
- ✓ Scaling up ACT anti-corruption in local governance sub-regional project

Capacities of human rights systems/institutions strengthened

- ✓ Facilitation of sub-regional consultations and programming approach in Central Asia including regional consultations with NHRIs of Central Asia in partnership with OHCHR
- ✓ Policy development NHRIs and SDGs cross regional conference for 25 countries from Europe, Central Asia and Arab States
- ✓ NHRIs' capacity building in Albania, Bosnia and Herzegovina, Georgia, Kazakhstan, Kyrgyzstan, Moldova, Ukraine, Uzbekistan, Tajikistan, the former Yugoslav Republic of Macedonia and Turkey. New NHRI law adopted in Turkmenistan
- ✓ Rule of Law programme development supported in Albania, Belarus, Kyrgyzstan, Turkmenistan, Tajikistan, Turkey and Ukraine
- Regional project in Western Balkans on processing war crimes and enhancing search for missing persons prepared and facilitated
- ✓ SGBV sub-regional consultations in Western Balkans resulting a concept note for a sub-regional project.
- ✓ 5 Catalytic Facility Projects on Human Rights and Rule of Law (Turkmenistan (2), Albania, Uzbekistan and joint project Serbia/BIH on war crimes processing



Capacities of human rights systems/institutions strengthened

- ✓ National partners in SEE strengthened to address security deficits globally 6 deployment of 19 experts through RSSRP most notable the Gender Training of Trainers for African military and Gender Training for Forensics in Kyrgyzstan
- ✓ Citizen security enhanced through:
  - Regional cooperation and knowledge sharing on SALW control and standardization (3 meetings of SALW Commissions and bilateral exchange, <u>Gender</u> <u>and SALW study</u> and <u>Toolkit</u>);
  - Improved stockpile management (security upgrades of 6 storages; destruction of over 3,100 weapons; and training of over 120 personnel);
  - Improved weapons marking, tracing and registration (through equipment and software upgrades, and training in 3 countries and territories; SEEFEN meetings, knowledge products (Feasibility Study);
  - Improved transparency of arms exports through publication of 2 national reports;
  - Awareness raising; through public awareness campaigns on dangers of misuse of firearms in 5 countries and a regional social media campaign



Capacities of human rights systems/institutions strengthened

#### ✓ Improved security sector governance

- Increased gender awareness in the Armed Forces through Regional Network of Gender Trainers (over 300 MoD and AFs personnel attended gender training)
- More gender responsive human resources policies and more empowered gender equality mechanisms in the military (implementation of Gender Coach Program in Montenegro lead to more gender sensitive policies; improvement of access to physical training in BiH lead to better retention of women, participation of 9 women officers in specialized courses lead to better professional development for women in the military



Capacities of human rights systems/institutions strengthened

- ✓ Central Asia (CA) regional approach:
  - May 2016 Regional consultations on HR, ROL and accountability in Central Asia for exchange between programme staff, leverage national expertise at sub-regional level and identify sub-regional priorities for possible resource mobilization at subregional level (Increased collaboration and knowledge sharing)
  - November 2016 Regional consultation for NHRIs from CA countries jointly with OHCHR Regional Office of CA. Roadmap developed on NHRIs' capacity development, partnership and peer-to-peer support (Joint UNDP-OHCHR proposal is in the making)
- ✓ Regional War Crimes



### Key priorities for 2017 Output 2

Capacities of human rights systems/institutions strengthened

- ✓ Human rights and security including as part of CVE/PVE
- ✓ Further integration of human rights, justice and security policy and programme support
- ✓ Further development of sub-regional approach to programming in Central Asia -SDG 16, NHRIs, PVE
- ✓ Further development of sub-regional approach to transitional justice in Western Balkans
- ✓ Policy guidance on NHRIs role with regard to SDG implementation jointly with Arab States
- ✓ Further strengthening of citizen security and security sector governance in ECIS through Regional Security Sector Reform Platform
- ✓ RM for a sub-regional project on combatting SGBV
- ✓ Further RM for SEESAC portfolio

Planned budget: \$372,157



Measures in place to increase women's participation in decision-making processes of national governance institutions, including post-conflict situations

- ✓ Published report "<u>Strengthening Women's Political Participation: An analysis of the impact of women's parliamentary networks in Europe and Central Asia</u>"
- ✓ Regional study on Gender Equality in Public Administration was finalized (to be published in spring 2017).
- ✓ Organized <u>Sub-regional conference</u> on advancing gender equality in W. Balkans and Turkey, with UN Women and the Council of Europe (Montenegro, 12-13 December 2016)
- ✓ <u>Meeting of Practitioners for Gender Equality</u> (Istanbul, 4-7 April 2016). 25 UNDP staff from 16 Country Offices participated in four-day workshop to discuss regional approach to strengthen gender equality and women's empowerment through programming to advance the SDGs



#### Key achievements 2016 Output 4 (cont'd)

- ✓ Commissioned guidance note on gender equality and SDGs, with UN Women, UNFPA, UNICEF, for use by UNCTs and agencies in the region (to be published in 2017);
- ✓ Supported seven Country Offices in Gender Equality Seal: Montenegro, Turkey, Albania, Armenia, Moldova, Belarus and Kosovo (UNSCR1244). Worked with COs on Seal action plans. Montenegro won Gold certification in spring 2016, the rest will be certified in early 2017;
- ✓ Gender equality results and good practice in women's political empowerment published, e.g., <u>regional website</u>, regional <u>Closing the Gap Report</u>, <u>Fast Facts</u> and <u>Spotlight: Gender Equality in Europe and Central Asia magazine</u>.

## Key priorities for 2017 Output 4

Measures in place to increase women's participation in decision-making processes of national governance institutions, including post-conflict situations

- ✓ Workshop to follow up on Montenegro conference and set up regional platform to advance gender equality commitments in Western Balkans and Turkey (with EU and CSOs)
- ✓ Sub-regional workshop/conference to implement recommendations of parliamentary gender caucus report
- ✓ Support COs in implementation of Gender Equality Seal and implementation of the regional Gender Marker Campaign

Planned budget: \$35,000



#### Challenges, risks and opportunities

#### <u>Challenges</u>

- ✓ Strong influence of political parties agenda in national policies and laws.
- ✓ Inadequate platforms/tools/venues for CS and citizens, and enhancement of social divides
- ✓ Poor quality and availability of data/evidence
- ✓ Poor delivery of public services (part. in rural areas)
- ✓ Incomplete decentralization reform
- ✓ Inadequate knowledge on efficient service delivery models
- ✓ Vulnerable groups, including ethnic minorities, left behind the development process
- ✓ Policies/laws do not recognize particular needs of vulnerable groups
- ✓ In response to rising radicalization and violent extremism, a tendency of disproportionate expansion of security at the expense of human rights



#### Challenges, risks and opportunities

#### **Risks**

- ✓ Increased securitization are prioritized over the good governance agenda
- ✓ Political volatility and rising nationalism threaten existing progress and continued political commitment to further reforms
- Continued politicization of the civil service stifle progress and capacity of the civil service to carry reforms and deliver fairly
- ✓ Increasing weakness in key geopolitical partners and changing political dynamics in the region.



#### Challenges, risks and opportunities

#### **Opportunities**

- ✓ Openings in Central Asia (Turkmenistan and Uzbekistan) for increased engagement on human rights and rule of law
- ✓ Increased interest in regional exchange in Central Asia
- ✓ Operationalization of 3RP in Turkey, with increased role of UNDP in governance and rule of law areas
- ✓ UNDP/UN's engagement on rule of law and dealing with the past in Albania
- ✓ Expansion of the Open Government Partnership and the leadership role of Georgia in 2017/2018
- ✓ Openings in restricted spaces for working politically around issues of open data
