Dear Mr. Gettu:

On behalf of the United States, I am pleased to inform you that, under the authority of the Foreign Assistance Act of 1961, as amended, the Government of the United States of America, through the U.S. Department of State's Bureau of International Narcotics and Law Enforcement Affairs (INL) will provide \$1,132,015 to the United Nations Development Program (UNDP) for operational support, equipment, and training for the Coordination Nationale de Soutien aux Activites Humanitaires et du DIS (CONSAHDIS) and the Détachement Intégré de Sécurité (DIS). UNDP will provide INL with a detailed budget breakdown and monitoring and evaluation plan prior to the release of the funds. The activities under this proposal are expected to be completed within 14 months. Your countersignature on this letter and your accompanying acknowledgment letter will acknowledge acceptance of these funds and your agreement to comply with the terms and conditions set forth in this letter. UNDP will administer the funds in accordance with its regulations, rules, policies, and procedures, and with the terms and conditions herein.

The actions to be taken and the resources to be provided by the U.S. government to UNDP in support of the enclosed project proposal are set forth in this letter and the project proposal. None of these funds may be used for other programs without our express consent. Future funding for extensions of this project by the U.S. government is contingent upon the availability of duly authorized and appropriated funds, satisfactory progress toward project goals, and approval by the U.S. Department of State.

UNDP is to provide INL with program and financial reports on the activities undertaken with these funds, with particular attention to the performance indicators enumerated within the project documents, in line with UNDP's reporting policies and procedures. UNDP confirms that the project account will be audited applying established procedures under appropriate provisions of the financial regulations and rules of the UNDP. UNDP agrees to disclose these audited reports to the U.S.

government in accordance with the UNDP Oversight Policy and relevant decisions of the UNDP Executive Board. These reports should be submitted not later than thirty days after the end of each quarter. A final report should be provided upon completion of the project, within six months of the completion date. The terms and conditions of the project may be amended by mutual written agreement.

The U.S. government shall be subject to any and all U.S. laws and regulations, including the obligation in some cases to take appropriate measures or if necessary to terminate assistance if a recipient organization or key individual of such organization is found to have been convicted of a narcotics offense or to have been engaged in drug trafficking or gross human rights violations, under this funding letter of agreement. Consistent with its requirements under section 620M of the Foreign Assistance Act of 1961, as amended, the U.S. will not provide funds to furnish assistance, including training, to any member or unit of security forces (including customs and border police) where there is credible information that such member or unit of security forces has committed a gross violation of human rights.

Consistent with numerous United Nations Security Council resolutions, including S/RES/1269 (1999), S/RES/1368 (2001), and S/RES/1373 (2001), both the Department of State and the recipient are firmly committed to the international fight against terrorism, and in particular, against the financing of terrorism. It is the policy of the Department of State to seek to ensure that none of its funds are used, directly or indirectly, to provide support to individuals or entities associated with terrorism. In accordance with this policy, the recipient undertakes to use reasonable efforts to ensure that none of the Department of State's funds provided under this letter of agreement are used to provide support to individuals or entities associated with terrorism.

In addition, should members or units of police or other security forces be proposed as candidates for the training pursuant to this letter and in accordance with the Concept Note, the Department of State understands that UNDP will carry out the selection process of those candidates in accordance with the selection criteria as defined in the Concept Note.

U.S. law does not permit UNDP to earn interest on funds provided to UNDP. If interest is earned on any such U.S. funds, please provide us with a year-end accounting and send to my attention a certified check made out to the United States Treasury for the amount of earned interest, through the U.S. Mission to the United Nations in New York.

We anticipate that the UNDP will do all in its power to minimize overhead costs so that funding can be directed towards implementing specific project proposals.

To comply with U.S. procedures for obligating these funds to UNDP, please confirm to me in writing as soon as possible your receipt of and concurrence with the terms and conditions set forth in this letter. Our receipt of this letter with your countersignature below and your accompanying acknowledgement letter indicating your acceptance of the terms and conditions herein, will serve as the official obligation of U.S. funds. The funds provided herein will be transferred to UNDP as soon as practicable following my receipt of your acceptance.


