**Substantive Progress Reporting** 

Substantive reports shall detail achievements, constraints and impacts with regard to the utilization of this contribution. The substantive report for the period will be submitted to OHCHR no later than one hundred and eighty (180) days after the date of completion or termination of the Agreement. This report will be accompanied by the preliminary financial report signed by the Resident Representative of UNDP Timor-Leste.

The final substantive report detailing achievements, constraints and impacts with regard to the utilization of the contribution from the country office and the final financial report, certified by the Office of Finance and Administration of UNDP, will be provided no later than 30 June of the year following the financial closing of the project.
