## 1. Opening remarks from Ministry of Social Solidarity by H.E. Ms. Isabel Amaral Guterres:

H.E Minister briefly welcomed all participants and appreciated to have the board meeting. After brief introduction, Minister requested the CTA, Ralf Ernst, to present on the project progress and expenditures. The programme officer introduced Mr. Gil da Costa, Assistant Country Director, on behalf of UNDP.

## 2. Project update from UNDP by Mr. Ralf Ernst, CTA/Project Manager

Mr. Ernst presented the project progress in 2015 and the annual work plan for 2016 on behalf of the UNDP.

#### 3. Discussions and comments

Discussions were taken during the presentation and comments made by outputs are summarized below:

Output 1: Institutional & Legal System for Disaster Risk Management (DRM) strengthened and capacities of relevant stakeholders built at different levels for effective DRM:

- Minister of Social Solidarity (MSS) has sent copies of National DRM Law and Policy to Minister of Interior (MoI) for review before submission to Council of Minister (CoM).
   Dates for presentation at CoM will be confirmed by MSS. MSS will also advise on further work to be conducted on the Policy and Law.
- MSS requested UNDP to continue supporting the NDMD accountability database, including through a consultancy under the DARDC Project.
- DRM training with INAP is part of DARDC project.
- MSS will set up a technical working group to develop plan of action on Sendai Framework.

Output 2: Enhanced capacities and systems of national and local level institutions to manage disaster risks; including improved national and local level coordination mechanisms

- UNDP suggested a joint scoping mission to Oecusse Region to review the disaster management structure and how the project can support on DRR.
   Action: project to draft a letter for MSS by last week of February. The letter will be sent by MSS to President of ZEESM.
- Trainings conducted to communities in Liquisa and Bobonaro on disaster resilient housing. The training was on how to build a sample house for a vulnerable household.
   MSS requested a briefing on this and a review of the list of recovery materials provided to the community post-disasters.

## Output 3 End-to-end early warning systems established and operational

 MSS mentioned on the changes on the organic law in regards to the disaster response which is now under the Ministry of Interior (MoI) while MSS will coordinate the humanitarian support. The DRM-2 and DARDC projects will take this into account for further activities.

Output 4 Systems established and Capacities enhanced for early recovery programming in Timor-Leste

- MSS requested to conduct a refresher training to DDMC members on DRR.
- Early Recovery Plan for Timor-Leste will be developed in the first quarter of 2016
