Brief Description

The objective of this project is to assist the Government of Turkey (GoT) in the formulation of a coherent and comprehensive National Action Plan for IDP service delivery, by replicating the participatory, context-specific and multi-stakeholder consultation approach adopted in the preparation of the Van Action Plan, which resulted in a provincial level pilot project for service delivery to IDPs. The GoT plans to replicate this approach in the remaining thirteen provinces where the Return to the Village and Rehabilitation Project has been implemented.

Designed as a replication of the formulation process of the Van Action Plan and in the scope of this component the following activities will be undertaken: Activity 1: Technical Assistance for the Development of a National Action Plan on IDPs based on the principles and methodologies of the Van Process; Activity 2: Feasibility Study of Provincial Action Plans Activity 3: Formulation of a National Action Plan; and as complementary the development of the Strategy Document and the required legislative framework; Activity 4: Development of a Communication Strategy.

Part I

1. Situational Analysis

Substantial internal displacement took place in southeast Turkey from 1985–1997 due to terror and armed conflict. In Turkey's EU accession discussions, the issue of internally displaced persons (IDPs) figures significantly in both political and economic criteria for accession. Subsequent Regular Reports on Turkey's progress towards accession refer to the situation of IDPs in Turkey.

The involvement of the UN with the IDP issue is grounded on the 2002 mission by Mr. Francis Deng, UN Secretary General's Special Representative for Internally Displaced Persons and the subsequent mission report (ref. E/CN.4/2003/86/Add.2). The report by Mr. Deng notes that while the Government of Turkey (GoT) discussed efforts to bring about return, programmatic attention paid to the current conditions pf the IDPs has not been systematic. Additionally, NGOs identify a range of social and economic needs of IDPs, and there is a lack of clarity and consultation undertaken in the development of a return program. The report by the UN Secretary General's Special Representative for IDPs also emphasizes the need for the GoT to clarify and publicize its policy on IDPs. The report furthermore states that the prerequisites for a return program should include the collection of data concerning the nature and scale of the problem, the need for the government to initiate a dialogue with IDPs, NGOs and CSOs and for appropriate legislation that would allow compensation to be paid to returnees.

The report by the UN Secretary General's Special Representative on IDPs, supplemented by internally generated reports produced by UNDP, has enabled the UN to promote a more strategic focus to the issue of IDPs, highlighting four important prerequisites for return:

- The need for the GoT to clarify and make explicit its policy on internal displacement and reintegration
- The need for the UN to monitor human rights issues relating to IDPs
- The activities of the security forces to be circumscribed and the village guard system abolished
- The acceptance that the implementation of a program of return and reintegration is difficult, will take time, and requires the building of trust.

Underlying these prerequisites is the need to build partnerships between the government, NGOs, civil society and international organizations to support national capacity in implementing the policy on internal displacement and reintegration.

In May 2005, the new Representative of the Secretary General, Walter Kaelin, conducted a working visit to Turkey at the invitation of the Turkish Ministry of Foreign Affairs. UN Secretary General's Special Representative Walter Kaelin was briefed on the developments that have taken place since his predecessor's mission in 2002, including a survey to better determine the number of internally displaced persons, the development of an "Integrated Strategy Document on IDPs in Turkey", and the adoption of Law No. 5233. While recognizing and commending the initiatives undertaken by the Government of Turkey to

date in addressing the issues related to internal displacement, UN Secretary General's Special Representative Walter Kaelin also highlighted the continued challenges of implementing these initiatives as a means to facilitate IDPs to return to their villages, alternatively to identify and realize durable solutions for those who choose not to return.

II. Rationale

In 2003, GoT opened a dialogue with the international community on the IDP issue. Since then, UNDP has been actively engaged in assisting the GoT to develop policies and strategies to respond to the needs of IDPs. In this context, the following have been implemented:

- Development of a positive working relationship with the GoT on IDPs
- Mobilization of the UN Country Team to address the situation of IDPs in the context of regional and local development in southeast Turkey
- The bringing together of an international consortium composed by experts from the UN, WB and EC
- Establishment of a working relationship with the Brookings Institution Project on Internal Displacement in Turkey¹
- Provide technical advice to the GoT and others in the development of an IDP program
- Identification of the key issues associated with establishing an IDP program
- Development and implementation of a joint project with the GoT

The joint project entitled "Support to the Development of an IDP Program in Turkey" was officially signed by the GoT in February 2006. The project was developed in partnership with government partners and with the UN Country Team's Working Group on IDPs. The aim of the project is to support government and civil society initiatives to develop a more comprehensive and robust response in identifying solutions for the IDP population in Turkey. The project consists of four primary components:

- Support to the Government-funded Survey on Internally Displaced Persons, as recommended by UN Secretary General's Special Representative on IDPs Mr. Francis Deng as a means to determine the quantitative and qualitative status of the IDP population given the absence of information in this regard;
- Capacity building and awareness raising among civil society and other national partners of the UN Guiding Principles on Internal Displacement and their practical application and relevance in Turkey
- A flexible component through which UNDP can meet additional priorities and needs identified by the government, civil society, or UN partners to further strengthen Turkey's response to IDPs to date.
- Formulation and implementation of a "pilot project" at the provincial level to develop, in close cooperation with national, provincial, and civil society partners, a

"service delivery model" for the internally displaced population to ensure access to services regardless whether the IDPs choose to return to their villages or to integrate into new communities.

In the scope of the "Support to the Development of an IDP Program in Turkey" Project, a number of significant policy and project related initiatives have taken place to fulfil the project's specific objectives, and more strategically to further advance Turkey's efforts in developing an IDP response as part of its own national development/reform agenda and in line with the EU Political Criteria. The realized initiatives can be summarized as follows:

- Survey on Internally Displaced Persons conducted by the Hacettepe University/Population Studies Institute completed and disclosed in December 2006.
 The Survey provides the first most comprehensive quantitative and qualitative countrywide data about the IDPs.
- Local and national NGOs capacitated about the international norms and standards on IDPs and Guiding Principles disseminated
- Technical knowhow provided to the relevant unit of the Ministry of Interior in charge of oversight and monitoring of the IDP-related policies for the development of tools serving improved standardization in compensation process, i.e. Valuation Matrix Tool, better access to information, i.e. website.
- Technical knowhow provided for the formulation of the Van Province Action Plan for the IDPs Service Delivery Model which is declared as a best practice by the Representative of Secretary-General due to its participatory, inclusive, contextspecific and multi-stakeholder consultation approach as well as for recognizing the need for developing and adopting holistic and well-structured policy responses for the IDPs.

The Van Province Action Plan for the IDP Service Delivery that was mentioned above, was prepared through multi-stakeholder consultation processes by the participation of all relevant partners including public sector, local administrations, civil society organizations (CSOs), private sector and IDPs themselves. Established platforms to the end of inclusive policymaking include local stakeholders meetings, focus group meetings, individual consultations, stakeholders workshops those results in oral and written policy recommendations and a baseline survey indicating the perceptions of IDPs in Van province. As a result, the Action Plan was presented and publicized by a high-level meeting that was held on 29 September 2006 in Van, co-organized by the Van Governorate, Ministry of Interior, and UNDP. At this stage, it is important to note that the adoption of the Van Action Plan and the political support provided to it by the Government of Turkey provide a unique window of opportunity to find durable solutions for many of the IDPs and a momentum that should be considered as a matter of urgency.

In that respect, the comprehensive and holistic approach is the innovative aspect of the Van Action Plan. Therefore, it provided an important and adequate instrument to the issue of internal displacement in Turkey with a view to find durable solutions and create social

cohesion. Furthermore, it focuses on the principle that IDPs can freely make their choices between return to their places of origin, local integration where they presently live, or resettlement to another part of the country, that was also one of the major points indicated in UN Guiding Principles on Internal Displacement. In that respect, in the Plan there has been a focus on displaced persons as active citizens, rather than only passive beneficiaries, whose needs are at the centre both of the process and the envisaged outcomes of the plan.

Since its launch on 29 September 2006, the Van Governorate has commenced the implementation of the "Van Province Action Plan" by adopting a participatory approach. The Governorate calls for the relevant social partners for joint initiatives for the implementation of the Plan. Parallel to the ongoing implementations at the local level, in relation to the response of GoT on IDPs, it is vital that government momentum be maintained in defining policy, developing administrative structures and in establishing operational modalities..

The project at hand aims to develop a national action plan by adopting a multi-stakeholder consultation process. The policymaking will commence at the provincial level, where the recommendations for a national policy response in relation to return, reintegration and rehabilitation will be collected and transmitted to national level. This exercise will take place in the thirteen provinces where the Return to Village and Rehabilitation Project (RVRP) has been implementing.

The RVRP is one of the initial policies of the GoT addressing to the needs of the internally displaced population in the country. Objective of the project is to establish sustainable livelihoods with required income generating means, social and economic infrastructure to relocate families that were forced to leave their places of residence and which voluntarily wished to return to their communities, the vicinities or in other areas with appropriate terrain. The 14 provinces covered in the Project are Bingöl, Hakkari, Tunceli, Bitlis, Van, Muş, Elazığ, Adıyaman, Ağrı, Diyarbakır, Batman, Siirt, Mardin and Şırnak.

III. Strategy

III.A Objective

The objective of this project is to assist the Government of Turkey in the formulation of a coherent and comprehensive National Action Plan for IDP service delivery, by replicating the participatory, context-specific and multi-stakeholder consultation approach adopted in the preparation of the Van Action Plan. The GoT plans to replicate this approach in the remaining thirteen provinces of RVRP.

III.B A Gender-Sensitive Approach

An important feature of this innovative step is to integrate a gender sensitive approach which has two dimensions. They relate to the selection of key stakeholders to participate in the process and allow for addressing the key needs of the IDP women.

Comprising half of the IDPs women, the economic situation of the women in most cases is extremely low. The myriad of factors specific to IDP women such as social practices and norms that still exists in the rural areas, and the lack of access to or control of natural

resources by IDP women means that there is a clear need for the proposed project to pay special considerations to the internally displaced women.

In order to address these concerns, below strategy was adapted during the preparation of the Van Action Plan:

- 1. In the course of the perception and expectation analysis, women social workers and university students from the relevant departments were recruited to more easily reach the internally displaced women and be accepted by them;
- 2. An important feature of these social workers and university students is they are being from the region. This was important since they were all aware of the social and cultural barriers that IDP women are facing;
- 3. Women are interviewed at their living spaces to avoid any alienation due to the questions asked in the scope of semi-structured interviews;
- 4. Women, including the internally displaced ones, are not a homogenous group; they often have conflicting priorities depending on their age, marital status and familial backgrounds. Focal group compositions recognized this diversity and responded to it.

In this phase of the Project similar approach will be adopted.

III.C Activities

Activity 1: Technical Assistance for the Development of Provincial Action Plans on IDPs based on the principles and methodologies of the Van Process

Parallel to the accelerated momentum, the launch of the Van Provincial Action Plan for IDP Service Delivery has contributed to the strengthening of participatory and inclusive policymaking processes on IDP related issues. The Van process is declared as a best practice in the UN system by the Special Representative of Secretary-General Dr. Walter Kaelin due to its participatory and inclusive approach. Through its global experience in dealing with internal displacement, UNDP recognizes that before any programme can be formulated to assist the return of IDPs, there is a need to develop a process whereby the concrete integration needs of IDPs are identified and assessed in a transparent way that contributes to sustainable return or integration into new communities for those who choose not to return, and social reconciliation. Preparation of Van Action Plan includes all relevant social partners including civil servants, professional organizations, local administrations, CSOs and IDPs themselves, in partnership with relevant government bodies.

By acknowledging the value of the Van process, Ministry of Interior and UNDP concludes that a replication of the process would be beneficial and vital in the context of Turkey for the sustainability and success of a larger programme, especially the political and social sensitivities surrounding this issue and the mixed results obtained by government programs to date. UNDP also highlights the potential of Turkey presenting its experiences for other countries facing the problem of IDPs. The strengths of Turkey's experiences that would

serve other countries as one 'model' of creating participatory and inclusive structures in relation to developing well-structured and holistic policy responses for IDP concerns. In this context, UNDP Turkey is committed to assist the Government of Turkey and other partners in replicating the Van process in the remaining thirteen provinces which are in the scope of RVRP. Within the scope of providing technical assistance for the replication of Van process UNDP will undertake the following activities:

- Mobilization of relevant stakeholders and social partners at the provincial level: In coordination with the governorates of thirteen provinces, meetings to introduce the principles, objective, activities and expected outputs of the process to relevant stakeholders and social partners will be held. At least one provincial level meeting will be held at the provinces. Where necessary, this can be increased.
- Various consultation mechanisms will be established at the provincial level: Various consultation mechanisms will be established at the provincial level to enable discussion of the existing problems related to internal displacement and possible solutions and policy responses with relevant stakeholders and social partners. These mechanisms and platforms will include semi-structured interviews, recommendation papers, focus group meetings and workshops. Workshops will be held on stakeholder basis; that is, workshops with public officials and local administrators; workshops with civil society organizations; workshops with private sector; workshops with academia and media. Overall 65 workshops will be held in thirteen provinces and policy recommendations will be developed by the relevant stakeholders that participate to the process.
- Informal meetings and semi-structured interviews with the IDPs: The component aims to create platforms where the internally displaced communities will express their preferences, expectations and priorities in relation to service delivery. These informal meetings and semi-structured interviews will be held both in the urban and rural areas. Due to existing cultural patterns, these meetings and interviews will be done according to age and gender. There will be approximately 150 meetings of this sort, which will be carried out simultaneously.
- Formulation of Provincial Action Plans to Address IDPs Needs: Established mechanisms and platforms will be the data collection means to identify provincial level service needs for the IDP communities. Collected data will be categorized and formulated by a mapping activity. This mapping activity will shape the provincial level action plan addressing to the service needs of the IDPs.

Activity 2: Technical Assistance for the Preparation of Feasibility Study on IDPs Requirements and National Action Plans

In order to create a sound ground for the implementation of the well-structured and holistic policy response for the IDP needs, feasibility study for each provincial level action plan should be carried out. Purpose of the feasibility study is to break down the defined objectives and scope of the project, the cost and benefits into measurable

targets and planned development actions, to further detail and analyze the scope and effort of the provincial level action plans in order to determine that they are feasible. The expected output of this feasibility study is to create a more detailed picture of what the provincial action plan is to accomplish and how this is going to be done. The feasibility study will show that there is a realistic opportunity for accomplishing the results and goals of the action plan. This feasibility study shall also cover first estimates of the resources, which will be useful in determining a suitable execution process.

UNDP will provide technical assistance to the fourteen governorates, including Van, in carrying out the feasibility study for the provincial action plans.

Activity 3: Technical Assistance for National Action Plan

Following the completion of provincial action plans through multi-stakeholder consultation processes (Activity 1), UNDP will provide technical support to the Ministry of Interior and other relevant national bodies for the formulation of a budgeted national policy document. In particular, UNDP will support the Ministry of Interior in synthesizing the different provincial level action plans outlining service needs of IDP's, and formulating a national level action plan based on the findings of the provincial level. Following the finalization of the National Action Plan, the Strategy Document and the required legislative framework will be developed.

Activity 4: Development of a Communication Strategy

The process which will be distinguished by a participatory and inclusive consultation approach will be shared with the public at large. The expected benefit from this broader communication is increased ownership and visibility of the endeavors in such a bottom-up policy making process. Various means to this end will be developed including documentaries, photographs, news bulletins and similar activities. In the deploy of this communication strategy, local media, local administrations and civil society organizations will be the main partners.

III.C Expected Outputs

- 1. Various participatory and inclusive decision-making platforms composed of the public officials, civil society organizations, local administrations, private sector and particularly the representatives of the IDP communities created in thirteen provinces in the course of the project.
- 2. Provincial action plans for IDPs service delivery formulated in thirteen provinces where the Return to the Village and Rehabilitation Project is carried out by multi-stakeholder consultation processes by the end of the fifth month.

- 3. National Action Plan formulated through the compile of fourteen provincial action plans by the end of the eighth month.
- 4. Feasibility Study prepared including the IDPs needs for fourteen provinces by the end of the eighth mounts.
- 5. Ownership and visibility of the IDP related practices and implementations of the Government of Turkey increased through the multi-stakeholder consultation processes and the community based approach which will be handled regarding the development of National Action Plan on IDPs.

III.D Sustainability of the Project and Exit Strategy

Multi-stakeholder consultation platforms are regarded as crucial means in participatory and inclusive decision-making. It is widely recognized that consultation platforms including different social partners can play important roles in the increased ownership and visibility of the initiatives. It is expected that created multi-stakeholder consultation platforms will be sustaining mechanisms at the local level.

The wide dissemination of the Van Action Plan to relevant ministries, general directorates, the Prime Ministry and academic institutions has already helped to create an environment for consolidating the progress so far. In that regard, the development of the National Action Plan and achieving similar results in other provinces affected by internal displacement will represent a decisive step in the exercise of Turkey's national responsibility for addressing, ending displacement and indicating the GoT's efforts on developing a social cohesion in the region. Thereby, this will increase the ownership of the National Action Plan and facilitate the effective implementation of the Plan in the future.

III.E Risks and Assumptions

The Government of Turkey expresses its commitment for durable solutions for the IDPs at various platforms. The project at hand is regarded as a social project.

Despite the favorable environment for the implementation, there are some risk factors those may challenge the successful implementation such as increased tension and resulting security problems in the region, low ownership of the consultation processes, and reluctance of some social partners to participate in the consultation process.

In case that these risk factors become reality following course of actions can be adopted:

- Project management will concentrate in the areas where minimum ownership has been achieved through analysing the situation, identifying the factors challenging ownership and addressing to these factors.
- If the security becomes a serious factor to carry out consultations, process will be postponed until normalization.

Where the problem of reluctance of some social partners to participate in the consultation process is faced reasons lying beneath this reluctance will be identified. If the reluctance is related to the partners' preference not to come with other partners due to confidence or unsound relations, then different platforms can be created to have the voices of these reluctant partners.

Part II. Project Management Arrangements and Coordination Mechanisms

The project is considered as a joint initiative of the Government of Turkey and UNDP. The project will be executed by the Ministry of Interior (MoI). Within the Ministry of Interior the project focal point is the Provincial Administration General Directorate.

UNDP will act as the **implementing agency**. UNDP will provide its relevant knowledge and expertise in facilitating multi-stakeholder consultation processes. UNDP will be the responsible party to implement the activities in the field (in the 13 provinces) coordinating the activities with the relevant stakeholders and complying with the monitoring and evaluation reporting requested by the Ministry of Interior.

UNDP Turkey will designate Democratic Governance Program Manager (PM) for the overall management of the project. In the scope of this, the PM will be responsible from the facilitation of project implementation at the national level by coordinating and oversee the execution of activities, be responsible for technical and methodological issues, and carry out any reporting functions required for monitoring and evaluation of the project, coordinate with governmental institutions, universities, NGOs and other relevant stakeholders including the IDPs. The Project Manager will among others, ensure the strategic cooperation with the Mol and SPO on all aspects of project implementation and contribute to the substantive development of the project activities in line with the national framework for IDPs and the International standards for IDP return, reintegration or integration into their new communities in line with overall UNDP programming priorities. In addition, the Project Manager in this coordination role will draft the work plans, arrange the field level activities and manage the overall project activities at the local level for the preparation of provincial action plans. The terms of reference (ToR) indicating the whole tasks and responsibilities is attached (Annex III: Terms of References for Project Manager). Numerous short-term consultants will be employed also. Short-term consultancy will vary depending on the requirements; but they will be mainly sociologists and development practitioners who have experience in field level activities and facilitation of multi-stakeholder consultation processes.

The costs of all project staff and personnel will be met from the resources of the project at hand. The costs of the UNDP program management will be borne by UNDP. The UNDP will implement the entirety of project activities in line with UNDP financial rules and regulations and report to the national designated agency (the Ministry of Interior) on quarterly expenditures through the Combined Delivery Report.

Depending on the requirements of the work, both short term international and national consultants will be recruited. (Annex IV: Terms of References for National and International Short Term Consultants)

The Project Steering Committee (PSC) is composed of the Ministry of Foreign Affairs, the State Planning Organization, the Ministry of Interior and UNDP. The PSC will be responsible for making on a consensus basis management decisions for the project, provide the overall guidance to the project implementation, monitor project outputs and their contribution to overall national development goals. The PSC will meet quarterly to provide policy guidance, review the work plan and implementation progress, and evaluate the updated project outcomes.

Part III. Budget

Up to date, the financing of the activities conducted by UNDP has been through the utilization of UNDP core resources and third party cost-sharing contributions, including funds from the Brookings Institute and Swedish International Development Agency (Sida).

Estimated budget for the component is 403.000 USD. Expected government cost sharing is 200.000 USD while UNDP will raise the remaining 203.000 USD from its own resources. The work plan and budget breakdown is provided below (Table 1, Table 2).

Part IV. Monitoring and Evaluation

Progress of the overall project activities will be shared with the relevant partners through periodic reporting:

<u>Ouarterly Progress Reports:</u> UNDP, as the implementing agency, will prepare Quarterly Progress and Financial Reports for this project.

Annual Progress Reports: UNDP will prepare an Annual Project Report at the end of the year. This report will be a comprehensive one that assesses the performance of the project.

The project will be audited, in line with the UNDP audit requirements, once in its lifetime at a minimum. Adequate financial provisions for the audit are included in the project budget.
