Brief description of the project, its objectives, etc.

The Albertine Rift Eco-Region is the most important forest system in Africa for biodiversity, extending across the Great Lakes Region of East and Central Africa (DRC, Uganda, Tanzania, Rwanda, Burundi). However, the forests have been under increasing threat from growing commercial demands and from rural communities whose high levels of poverty make them dependent on forest resources for their livelihood. These pressures on the forest resources, coupled with weak conservation agencies at decentralized levels, and as yet untried collaborative forest management strategies with local people, have led to considerable loss of forest cover, especially on private and public land. This GEF project provided additional resources to the Government of Uganda and partners to implement innovative conservation activities in Planning Unit One - the Northern Albertine Rift Forests of Uganda. The project developed a Strategic Plan for the northern Albertine Rift under the Regional Framework, including a coherent M&E strategy. Project activities included support to collaborative forest management, capacity strengthening of the National Forest Authority for improved management of Central Forest Reserves, strengthening and maintenance of linkages between these protected areas through incentives for forest conservation on private land, and promotion of incentives for alternative resource use strategies and conservation on private lands. The project addressed the issues outlined in Strategic Priority BD1, and partially those of BD2, of the GEF. The project was implemented by WWF in conjunction with the Ministry of Water and Environment as an executing agency that set up a Steering Committee for the project, appointed a National Project Coordinator and set up a Project Management Unit.
