Form of Contribution Arrangement for Co-financing between the Department for International Development (DFID) and the United Nations Development Programme (UNDP)

- 1. I am pleased to inform you of the intention of DFID to make available a contribution (the "Contribution") of £300,000 (Three hundred thousand pounds only) as a grant, to be administered by UNDP for UNDP Thematic Trust Fund for Support to Energy and Environment for Sustainable Development established by the Administrator of the UNDP on 14 October 2004, and which Terms of Reference are attached to this Agreement as Annex 1; DFID project number 201295-101. UNDP will administer the Contribution in accordance with the provisions of the Framework Arrangement, except as otherwise provided herein.
- 2. The Contribution will be used exclusively for the following to implement the project "Low-carbon and climate resilient local development in the Mbale region of Uganda" as laid out in the project document, and the terms of reference of the Trust Fund attached in Annex 1.
- 3. In accordance with UNDP's cost recovery policies, the Contribution will be subject to cost recovery for indirect costs (General Management Support (GMS) and specialized technical support services) of 12%. Furthermore, as long as they are unequivocally linked to the specific project(s), all direct costs of implementation, including the costs of executing entity or implementing partner, will be borne by the project and reflected in the project budget.
- 4. The Department for International Development (DFID) will deposit the Contribution as a grant with UNDP, upon request from UNDP, in UNDP's Bank Account:

£100,000 by 31/01/2010, £100,000 by 31/01/2011, £100,000 by 31/01/2012.

The above schedule may be amended by mutual consent of UNDP and DFID dependent upon actual and estimated expenditure and need. DFID will notify UNDP Headquarters of each payment using the attached form (Annex 2). The execution/implementation of the responsibilities of UNDP and of the Executing Entity/Implementing Partner pursuant to each Contribution Arrangement will be dependent on receipt by UNDP of the contribution in accordance with the schedule of payment. Should such financing not be available, the assistance to be provided to the project may be reduced, suspended or terminated by UNDP.

- 5. UNDP will provide to DFID with each request for payment, presented in accordance with this Section, a *financial utilisation report* of: -
 - a) all amounts previously received under the Contribution Arrangement (in US Dollars and UK Pounds sterling);
 - b) prior year's expenditure, current year's expenditure to date and unutilised budget to-date under the Contribution Arrangement (in USD\$); and
 - c) the requested amount from the Programme Budget Allotment .
- 6. For cost sharing projects, it is expected that the Contribution funds will be fully utilised in accordance with the provisions of this Contribution Arrangement by 31/07/2012. UNDP will notify DFID of any anticipated unspent balance of funds at least three months before the expected project end date, and UNDP will only disburse the funds for the purpose of this Contribution Arrangement after such date upon the approval of DFID. Once the project has been completed, unspent funds held by UNDP will be returned to DFID as set out in Annex 3.

- 7. UNDP will promptly inform DFID of any significant modification to a programme or project co-financed by DFID under this Contribution Arrangement. UNDP will also inform DFID of any events which, in the opinion of UNDP, interfere or threaten to interfere with the successful implementation of any programme or project financed by this contribution.
- 8. If at any time, either Participant determines that the purposes of this Contribution Arrangement can no longer be effectively or appropriately carried out, or if the Framework Arrangement is terminated, this Contribution Arrangement may be terminated at the initiative of either Participant by giving three (3) months written notice. Such termination will not oblige UNDP to repay any funds until satisfaction of all commitments and liabilities.
