Brief Description

The Project Document is revised to reflect an increase of the overall Project budget by USD 185,200.00 due to:

1.) new Output 4 "Strengthening National health care system to ensure effective diagnostics and treatment of tuberculosis". Over 2012-2013, the Project is expected to strengthen abilities of the state and civil society sector institutions to ensure high quality diagnostic and treatment of the tuberculosis as one of the HIV opportunistic infections, including at the regional level. These activities will be cost-shared by the Foundation "Development of Ukraine" and increase Project budget by USD 111,200.00.

2.) additional Unified Budget, Results and Accountability Framework (UBRAF) contribution amounting to USD 74,000.00. Over 2012-2013, the UBRAF contribution will support to the efforts of Country Office: (i) to address the political and legal barriers for appropriate addressing HIV-related issues among key populations by strengthening partnerships and legislative frameworks; (ii) to strengthen the financial sustainability of HIV/AIDS programmes in Ukraine; and (iii) to create and implement a mechanism for patient-centered monitoring of services that feeds into policymaking.

The overall objective of the Project remains to strengthen national capacity for effective HIV/AIDS response and to accelerate health related MDGs, applying human rights and gender-based approaches. The Project will complement the activities of other international donors and will contribute to the implementation of the Joint UN Programme for Support on AIDS for 2012-16. UNDP will closely align its HIV/AIDS support with the identified national priorities and will fill in existing gaps to achieve short and long-term priorities. The specific Project objectives are: (i) to strengthen abilities of the state and civil society sector institutions to effectively plan, implement, monitor and evaluate national and sub-national multi-sectoral HIV/AIDS strategies and action plans, and to promote healthy life style with the special focus on youth; (ii) to promote prevention and reduction of risks of HIV/AIDS infection among youth with special needs, most at risk youth, pregnant women who use drugs, as well as youth who live or work at streets; (iii) to develop capability of the public sector institutions in protecting the human rights of people affected by HIV/AIDS, especially youth; to address gender and HIV linkages in policies and plans; and to ensure provision of equal access to prevention, treatment, care and support services for men who have sex with men and transgender people; (iv) to strengthen PLWH community in EECA countries to ensure sustainable, favourable environment in EECA region to achieve universal access to HIV/AIDS prevention, treatment, care and support, especially for youth, based on international standards of human rights.

I. SITUATION ANALYSIS

Ukraine continues to experience the most severe HIV epidemic in Europe, with the estimated 1.3% adult prevalence rate of HIV infection totalling to approximately 360,000 people. According to the State AIDS Centre only 197,083 people infected by HIV are officially registered, including 43,775 people with AIDS. Thus, only 30% of people living with HIV are aware about their status. Other statistics related to HIV/AIDS is also alarming: only 10% of the current needs in antiretroviral treatment (ART) are met in Ukraine, and only 40% of young people have correct knowledge of HIV/AIDS and its prevention. Moreover, most-at-risk populations, including adolescents, as well as people living with HIV, have limited access to prevention, treatment, care and support services. This increases their vulnerability and risk of contracting and dying of HIV/AIDS. With regard to prevention of the disease, according to UNGASS 2010 Country Report, only 32% of injecting drug users, 63% of men having sex with men, 59% of commercial sex workers, and 15% of prisoners have access to prevention services. Another serious challenge for Ukraine is to tackle the high rate of tuberculosis co-infection, one of the most commonly met opportunistic infections that hit HIV positive people, that reaches over 60% in some regions of the country, and the continuous growth of the TB/HIV mortality (0.1 in 1999 compared with 3.9 in 2007 and 5.5 in 2009 per 100,000 of population).

The National Programme of HIV Prevention, Treatment, Care and Support for HIV Positive People and AIDS Patients for 2009-2013 (hereinafter - the State Programme) is the key governmental strategic document which forms the basis for the national response to HIV/AIDS. Importantly, it set specific measures to stabilize HIV/AIDS related morbidity and mortality by ensuring access of population to large-scale prevention, treatment, care and support services for MARPs, HIV-infected and AIDS patients. Despite important achievements in the increase of coverage of treatment, expansion of services for prevention, care and support, it is clear that majority of the State Programme targets will not be achieved by 2013. Through the comprehensive evaluation process the Government plans to develop a new National AIDS Programme for 2014-2018 to incorporate evidence-informed, prioritized, efficient and costed prevention, treatment, care and support interventions addressing MARPs, human rights and gender equality.

The implementation of the State Programme involves a complex and close cooperation among the network of different institutions, including (i) central executive authorities: Ministry of Health of Ukraine, State Service for Countering HIV/AIDS and Other Socially Dangerous Diseases, National AIDS Centre, State Penitentiary Service of Ukraine, Ministry of Education, Science, Youth and Sports of Ukraine, State Service for Youth and Sports of Ukraine, Ministry of Defence of Ukraine, State Committee on Television and Radio Broadcasting, Ministry of Social Policy of Ukraine; (ii) local executive authorities: Council of Ministers of the Autonomous Republic of Crimea, oblasts, Kyiv and Sevastopol cities administrations, Regional AIDS Centres; (iii) NGOs, including GFATM principal recipients (International HIV/AIDS Alliance and All-Ukraine Network of People Living with HIV); and (iv) the Academy of Medical Science, National Academy of Sciences and the Council of Churches; among others. Finally, the National Council on Tuberculosis and HIV/AIDS performs oversight over the implementation of the national response to HIV/AIDS and functions as the country coordination mechanisms, in compliance with the GFATM requirements.

There is a broad recognition among all stakeholders that to reverse the negative HIV/AIDS trajectory in Ukraine, significant increase of financial, human and technical resources is required.

Health, education and social services are thematic areas within which the UN is recognized as a global standard-setter and a source for technical and policy advice. Its specialized agencies, programmes, and funds have collectively formed a unique policy and capacity development platform to assist national partners. According to the Ukraine-UN Partnership Framework (UNPF) for 2012-2016, the UN system, among others, strengthens technical and institutional capacities within the Ukrainian health system to accelerate progress towards health related MDGs. Furthermore, the UN system fills a critical niche in advocacy and the provision of technical support for the national response, and in mobilizing additional financial resources, including coordinating the attraction of the GFATM resources into the country. The UN system, 3rd largest donor by the volume of investments, implements the Joint Programme of Support on HIV/AIDS, which envisages interventions for reduction of sexual HIV transmission; elimination of mother-to-child HIV transmission; promotion of universal access to treatment; creation of enabling (legal)

environment to reduce stigma and discrimination, and promotion of gender equality and human rights.

Efforts related to MDG 6 – reducing HIV/AIDS and TB – are an important component of the new UNDP Country Programme 2012-2016. Given the strong link between health and development, UNDP will assist the Government of Ukraine to address public health related challenges and prevent the spread of HIV/AIDS and TB, thereby contributing towards the MDGs and national socio-economic development objectives.

II. STRATEGY

UNDP recognizes that development action outside the health sector – in social protection, gender, human rights and environment – can contribute significantly to better health outcomes, especially for the most disadvantaged groups of the population. The Project, therefore, aims to build synergies between the HIV/AIDS response and broader Millennium Development Goals and to place human rights, equity and gender equality agendas at the centre of the HIV/AIDS response. Such an approach requires a major shift in coverage, content and resourcing of HIV programming, which this Project aims to contribute to.

In line with the agreed Division of Labour within the UN System in Ukraine, UNDP is the lead organization promoting laws, policies, and practices for effective HIV/AIDS response with the focus on youth. UNDP implements projects to empower youth, and men who have sex with men and transgender people to better protect themselves from HIV infection, and supports activities at the nexus of HIV/AIDS and gender and sexual based violence. UNDP also partners with other UN agencies in reducing the sexual transmission through access to treatment and services, promoting comprehensive HIV services for people in prisons and drug users, enhancing social protection for HIV affected people and supporting the development and implementation of multi-sectoral national HIV/AIDS programmes with the focus on youth.

Thus, in line with the abovementioned priorities, the overall objective of the Project is to strengthen national capacity for effective HIV/AIDS response with the focus on youth and to accelerate health related MDGs, applying human rights and gender-based approaches. The Project will complement the activities of other international donors and will contribute to the implementation of the Joint UN Programme for Support on AIDS for 2012-16. UNDP will closely align its HIV/AIDS support with the identified national priorities and will fill in existing gaps to achieve short and long-term priorities.

The specific Project objectives are:

- to strengthen abilities of the state and civil society sector institutions to effectively plan, implement, monitor and evaluate national and sub-national multi-sectoral HIV/AIDS strategies and action plans, and to promote healthy life style with the focus on youth;
- to promote prevention and reduction of risks of HIV/AIDS infection among youth with special needs, most at risk youth, pregnant women who use drugs, as well as youth who live or work at streets;
- to develop capability of the public sector institutions in protecting the human rights of people affected by HIV/AIDS, especially youth; to address gender and HIV linkages in policies and plans; and to ensure provision of equal access to prevention, treatment, care and support services for men who have sex with men and transgender people;
- to strengthen PLWH community in EECA countries to ensure sustainable, favourable environment in EECA region to achieve universal access to HIV/AIDS prevention, treatment, care and support, especially for youth, based on international standards of human rights;
- to strengthen abilities of the state and civil society sector institutions to ensure high quality diagnostic and treatment of the tuberculosis, as one of the HIV opportunistic infections, including at the regional level.

The Project will be implemented by the State Service on Youth and Sports of Ukraine, and will partner with a number of institutions that will include, but not limited to Ministry of Health of Ukraine, State Service to Countering HIV/AIDS and Other Socially Dangerous Diseases, Ministry of Education, Science, Youth and Sports of Ukraine, Ministry of Interior of Ukraine, Ministry of Social Policies of Ukraine, Ministry of Economic Development and Trade of Ukraine, State Penitentiary Service of Ukraine, Parliament of Ukraine, Judges, Prosecutors, National and Oblasts

AIDS Centres, Regional State Administrations, National Council on Tuberculosis and HIV, Regional Councils on Tuberculosis and HIV, NGOs (All-Ukrainian Network of PLWH, International Alliance on HIV/AIDS, Coalition of HIV-service organizations, Foundation "Development of Ukraine", "Gidnist", Gay Alliance, Gay Forum), East Europe and Central Asia Union of People Living with HIV, UN Agencies, UNAIDS Secretariat. It is planned that partners will be involved into the project activities through participation in the Advisory Board, various meetings, workshops and seminars, receiving services that will be framed by respective protocols, exchange of letters, etc.

The Project plans to also strengthen the organizational and advocacy capacity of the East Europe and Central Asia Union of People Living with HIV, including by providing grants to its members, namely : NGO "Real World, Real People" (Armenia), Public Organization Against AIDS (Azerbaijan), Republican non-governmental organization "Belarussian PLWH Community" (Belorussia), NGO "Real People, Real Vision" and Association "Georgian Plus Group" (Georgia); NGO "Terra Sana" and Association of legal entities "National Network of PLWH" (Kyrgyzstan), NGO "AGIHAS" (Latvia), Association "Pozityvus gyvenimas" (Lithuania), League of people living with HIV from Republic of Moldova (Moldova), Polish National Network of PLWHA "SIEC PLUS" (Poland), Russian Public organization "Association of People living with HIV" (Russia), Public Organization "Guli Surkh" and Public Organization "SPIN Plus" (Tajikistan), Initiative group of PLWH and their relatives of Fergana region "Hayot" (Life+) (Uzbekistan), All-Ukrainian Network of People Living with HIV/AIDS (Ukraine), NGO Estonian Network of PLWHIV (Estonia) with the aim to achieve universal access to HIV/AIDS prevention, treatment, care and support.

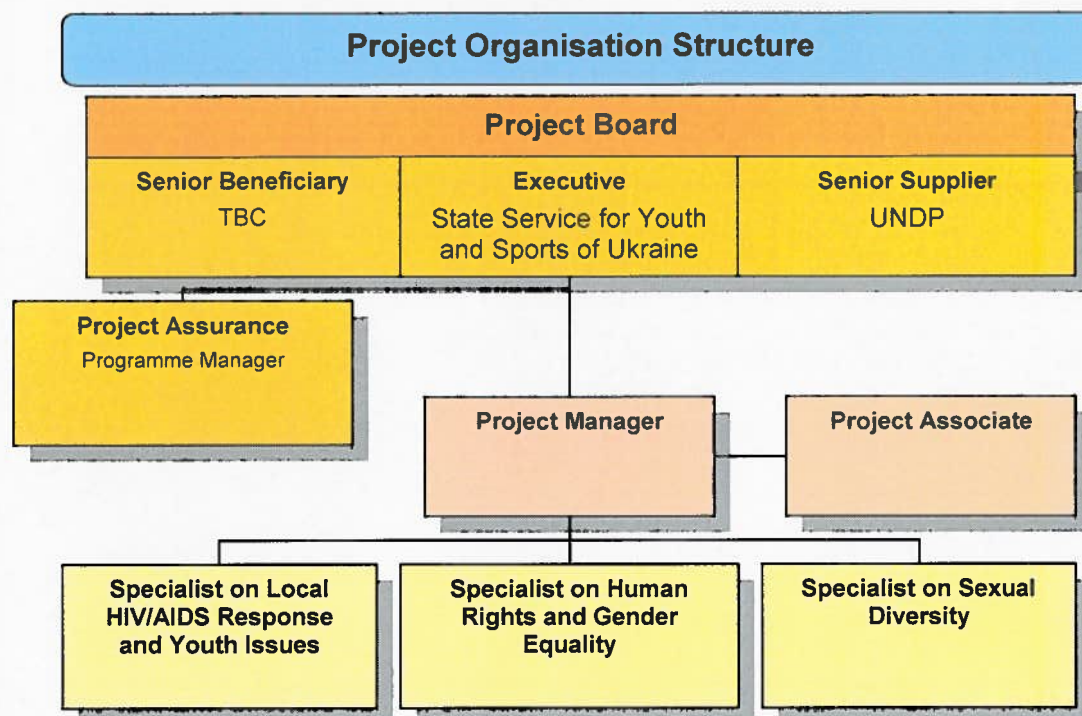

Implementing Partner: State Service for Youth and Sports of Ukraine will be an Implementing Partner. State Service for Youth and Sports of Ukraine makes an ideal partner as it is one of the leading institutions within the Government of Ukraine which is responsible for formulation and implementation of HIV/AIDS prevention policies.

Project Board: The Project Board is responsible for making, on a consensus basis, management recommendations for a project when guidance is required by the Project Manager. Particularly, the Project Board will have the responsibility to review/endorse project documents and revisions thereto, annual work plans, quarterly and annual project reports.

This Board contains three roles:

- Executive representing the project ownership to chair the group. For this project, the State Service for Youth and Sports of Ukraine will assume the role of Project Board Executive.
- Senior Supplier role to provide guidance regarding the technical feasibility of the project. This role will be assumed by UNDP.
- Senior Beneficiary role to ensure the realization of project benefits from the perspective of project beneficiaries. The assumption of this role will be defined at the first project board meeting.

To discuss strategic issues of the Project activities and impact, and to ensure that best available international and national expertise is given due consideration in formulation of the project strategy, the Project Board may decide to invite to its meetings other stakeholders.

Advisory Committee: The Programme will also establish an Advisory Committee, which will convene a broader group of stakeholders – including State Service for Youth and Sports of Ukraine, State Service to Countering HIV/AIDS and other Socially Dangerous Diseases, Ministry of Social Policies of Ukraine, All-Ukrainian Network of PLWH, International Alliance on HIV/AIDS, Gay Alliance, UNAIDS, etc. The objective of the Advisory Committee is to provide a forum for the Project to communicate and solicit stakeholder perspectives on Project plans, progress, results and risks.

Project Assurance: The Project Assurance role supports the Project Board by carrying out objective and independent project oversight and monitoring functions. This role ensures appropriate project management milestones are managed and completed. This role will be performed by a UNDP Ukraine Programme Officer.

Project Manager: The Project Manager has the authority to run the Project on a day-to-day basis on behalf of the Project Board within the constraints laid down by the Project Board. The Project Manager is responsible for day-to-day management and decision-making for the Project. The Project Manager's prime responsibility is to ensure that the Project produces the results specified in the Project document, to the required standard of quality and within the specified constraints of time and cost.

The Project team: The Project Team will consist of the following local staff:

- Project Manager (full time);
- Specialist on Local HIV/AIDS Response and Youth Issues (full time);
- Specialist on Human Rights and Gender Equality (full time);
- Specialist on Sexual Diversity (full time, subject to resource mobilization);
- Project Associate (full time).

The ToRs of the above-mentioned positions are attached to the present Project Document (See Annex 1). Contracts for services of individual contractors (for advisory and consultancy support) will be completed between UNDP and the selected experts for each thematic subject area in accordance with the approved work plan. The experts will be competitively selected based on an open competition, according to UNDP rules and regulations.

Grants. The Project plans to also strengthen the organizational and advocacy capacity of the East Europe and Central Asia Union of People Living with HIV, including by providing grants to its members, namely: NGO "Real World, Real People" (Armenia), Public Organization Against AIDS (Azerbaijan), Republican non-governmental organization "Belarussian PLWH Community" (Belorussia), NGO "Real People, Real Vision" and Association "Georgian Plus Group" (Georgia); NGO "Terra Sana" and Association of legal entities "National Network of PLWH" (Kyrgyzstan), NGO "AGIHAS" (Latvia), Association "Pozityvus gyvenimas" (Lithuania), League of people living with HIV from Republic of Moldova (Moldova), Polish National Network of PLWHA "SIEC PLUS" (Poland), Russian Public organization "Association of People living with HIV" (Russia), Public Organization "Guli Surkh" and Public Organization "SPIN Plus" (Tajikistan), Initiative group of PLWH and their relatives of Fergana region "Hayot" (Life+) (Uzbekistan), All-Ukrainian Network of People Living with HIV/AIDS (Ukraine), NGO Estonian Network of PLWHIV (Estonia) with the aim to achieve universal access to HIV/AIDS prevention, treatment, care and support.

VI. MONITORING FRAMEWORK AND EVALUATION

In accordance with the programming policies and procedures outlined in the UNDP User Guide, the project will be monitored through the following:

Within the annual cycle

- On a quarterly basis, a quality assessment shall record progress towards the completion of key results, based on quality criteria and methods captured in the Quality Management table below.
- An Issue Log shall be activated in Atlas and updated by the Project Manager to facilitate tracking and resolution of potential problems or requests for change.
- Based on the initial risk analysis submitted (see annex 1), a risk log shall be activated in Atlas and regularly updated by reviewing the external environment that may affect the project implementation.
- Based on the above information recorded in Atlas, a Project Progress Reports (PPR) shall be submitted by the Project Manager to the Project Board through Project Assurance, using the standard report format available in the Executive Snapshot.
- a project Lesson-learned log shall be activated and regularly updated to ensure on-going learning and adaptation within the organization, and to facilitate the preparation of the Lessons-learned Report at the end of the project
- a Monitoring Schedule Plan shall be activated in Atlas and updated to track key management actions/events

Annually

- **Annual Review Report.** An Annual Review Report shall be prepared by the Project Manager and shared with the Project Board. As minimum requirement, the Annual Review Report shall consist of the Atlas standard format for the QPR covering the whole year with updated information for each above element of the QPR as well as a summary of results achieved against pre-defined annual targets at the output level.
- **Annual Project Review.** Based on the above report, an annual project review shall be conducted during the fourth quarter of the year or soon after, to assess the performance of the project and appraise the Annual Work Plan (AWP) for the following year. In the last year of the project implementation, this review will be a final assessment. This review is driven by the Project Board and may involve other stakeholders as required. It shall focus on the extent to which progress is being made towards outputs, and that these remain aligned to appropriate outcomes.
