#### Introduction

Opening address by Mr. E. Tursunov: Short introduction and welcome address.

In his address, Mr. Tursunov highlighted that irrigated lands quality is a key requirement for social and economic well-being of the country. Therefore, Government has assigned high priority to this issue. Irrigated Land Reclamation Fund, created under special Presidential Decree, is a perfect example of this emphasis. Special Department to ensure effective management of the Fund's operations was created under the Ministry of Finance. Government assigns significant funds for land reclamation. In 2009, some UZS 144 billion budget got implemented, and 2010 budget will be equal or higher (around UZS 150 billion).

Further, Mr. Tursunov spoke about the main directions of collaborative activity under the Project's framework. The main objective of the Project is to provide support to the Fund in creating development mechanisms that would be based on analysis of global experience and the Project outputs. This is particularly relevant for provision of support in such important areas as updating legal framework for irrigated land reclamation, improving Fund's capacity in setting priorities for funding based on projects and programs meeting the requirements of international financial Achieving these objectives would facilitate, on one hand, higher efficiency and institutions. sustainability of government's funds investments into land reclamation, and on the other hand, this would open possibilities for the Fund to raise extrabudgetary funds, including international donors' and other investors' resources, for implementation of reclamation programs being developed. Other important cross-linked components of the Project activity are strengthening the existing system of land monitoring through introduction of best practices including express methods of measuring land and ground water salinity, improving capabilities of electronic cartography, wider application of remote control programs, satellite-aided monitoring and evaluating land condition. Achieving all the planned objectives would help the Fund ensure efficiency and sustainability of activities implemented within the framework of the Irrigated Land Reclamation Program.

In the end of his address, Deputy Minister expressed his hope that the Project outcomes would help reaching understanding of the modern methods of land quality improvement, providing more ample opportunities for priority setting in funding the projects while ensuring that the benefits match costs, integrating ecological and sociological evaluations into preparation and evaluation of programs and projects. The outcomes would also facilitate better understanding of land reclamation

in the context of agricultural activities in the country and improvement of the legal framework of managing the quality of irrigated lands in Uzbekistan.

## Welcoming Speech of Ms. S. Syed:

Dear esteemed Board Members,

I am glad to welcome you to the first Project Board Meeting of the "Capacity Building of the National Irrigated Land Reclamation Fund" project, launched in late 2009. The overall objective of the project is to build the capacities of the Fund Management Department of the National Irrigated Land Reclamation Fund, by improving national land reclamation policy planning and financing, streamlining functional effectiveness of the Fund Management Department for more effective management of irrigated land in Uzbekistan.

From UNDP perspective, application of improved land reclamation approaches in Uzbekistan will have a significant impact on the well-being of the population in the country, especially in rural areas. We believe that the global UNDP expertise in the area of sustainable land and water management, which we can also channel through this project, is timely to address these challenges effectively. #### U. Islamov's presentation on:

Overview and report on the activities implemented under 2009 Action Plan and presentation of 2010 Action Plan

The Project's main goal is to support strengthening capacity of the Fund for effective resolution of issues related to irrigated land reclamation. This includes institutional and organizational development, training the Fund personnel in the modern methods of financial management, project development and evaluation, strengthening land reclamation legal framework. The Project duration

is three years. Particular attention will be paid to IT-based management. Achieving of the following objectives is planned:

- Within the first component's framework, institutional, organizational and program evaluation will be performed to identify the base line;
- Second component is aimed at training of experts of the Fund and other relevant organizations in the modern methods of project proposal development and evaluation;
- Third component is designated to support improvement of the legal and regulative framework of the Fund and of land reclamation in general. Government support will play a decisive role in the success of this component;
- Within the framework of fourth component, pilot demonstration sites will be created in two regions of Uzbekistan. In these sites, best practices in land and water resource management, interlinked with the existing irrigated land quality monitoring system, will be demonstrated.

Activities under Component 1, related to performance of evaluations, will be implemented in the first quarter of the current year. Remaining part of the component will be implemented during the current year, with major activities to be fully completed in 2011.

Project Steering Committee was established to facilitate Project coordination and management, constituted of representatives of the Ministries and Departments involved. Steering Committee is chaired by the Deputy Minister of Finance. Support provided by the Steering Committee and the National Coordinator would facilitate achieving the Project goals and objectives. Support of UNDP and other stakeholders will also be required for successful Project implementation.

Proposal on item 1.1.4, capacity building plan should be made more concrete.

Work load of experts in the departments grows. We can see uneven distribution of work load between the departments. This leads to deterioration of quality of work.

The subcontractor is a reclamation expedition. They are given a volume of work worth up to UZS 60 billion, and there is a problem of whether they are able to implement this budget. We have to see if structure of the existing Oblast Hydrogeological-Ameliorative Expeditions (OHAE) is adequate to reach these objectives and prepare a proposal to improve it...It is necessary to include issues of improving the structure of the Fund itself, etc.

## 4. H.H. Eshonov

Chief Specialist, Information – Analytical Department for the Issues of Agriculture, Water Resources, Agricultural Produce Processing and Customers Goods under the Cabinet of Ministers of the Republic of Uzbekistan

During preparation of the Project, the Fund and Ulugbek Islamov, with UNDP support, took a significant effort. Presently, activity of the Department is supported with legal framework. On 25 December 2009, the law "On water and water usage" was updated with supplements and amendments reflecting the modern requirements. We also have the Land Code, which can serve as legal framework for irrigated land reclamation. In 2007, a Decree to organize activity of the Fund and a Resolution on activity of the Department were issued. Cabinet of Ministers adopted the Program for Ameliorative Improvement of Lands. Yet, at the same time, there are areas, which require improvement: First, Project priority setting is a weak point. Activity areas are defined and activities up to 2012 are listed, but at the local level situation is changing, lowering some of the projects' priority - attention should be paid to defining re-

evaluation criteria; Second issue is related to project solutions in complicated hydrogeological—reclamation conditions – there are sites where main collectors are affected by sloughing and erosion (Tashkent oblast, Fergana valley, etc.).

Third, Resolution # 320 dd. 21.07.2003 and Provisions of the Main Department of the Ministry of Agriculture and Water Resources stipulate that OHAEs are to evaluate reclamation activities, but unfortunately, this work is not being performed
