This final TPR is to review the project implementation and assess the results of the project. The conclusions of this meeting are as follows:

(1) Review and Assessment of the project implementation:

- The Project has achieved all objectives set by the Project Document.
- Project activities were carried out with high quality with significant impacts on the legal reforms of the country. Particularly, the project has successfully assisted Viet Nam in, inter alia:
 - + creating a legal framework for market economy and international economic integration for Viet Nam;
 - + improving the quality of legal drafting and reviewing, codifying of legal normative documents;
 - + improving the legal information and dissemination
- This project is recognised as one of the most successful projects.

(2) Project Management:

- The Project was managed by a Board of most senior officials of the Ministry. The commitment of the Ministry and of the Board in particular made the success of the project;
