Promote legal empowerment and ensure justice to all, and vulnerable groups in particular, remains strong and is an utmost national priority especially when Viet Nam is experiencing rapid changes as a newly emerged middle-income-country. Efforts are being made to strengthen the rule of law through increased effectiveness and responsiveness of justice institutions. However, more work is needed to improve these institutions' reliability, accountability and accessibility so they can address the widening inequalities and injustices that particularly affect women, children, and vulnerable groups including ethnic minorities, people with disabilities, survivors of gender-based violence and human trafficking and internal migrants. This is not the task of a single institution, but requires closely coordinate joint efforts and partnership among political, legislative, executive, and judicial institutions, and civil society organizations, at national and local levels.

Building on the key legal and constitutional reforms, such as the 2013 Constitution, the 2014 Law on Organization of the People's Courts and the 2015 Legal Aid Reform Project, this Project's overall objective is to strengthen the rule of law through a more reliable, trusted and better accessed justice system. More specifically, it aims to support increased access to justice for vulnerable groups and in particular for women, children, ethnic minorities, and poor people.

The objectives of the programme are envisaged to be achieved through four results, each one of which is to be realized by implementing a set of activities as outlined below.

Result 1: Increased public awareness and understanding of rights and how to invoke those rights.

Result 2: Increased access to legal advice, assistance and representation in both civil and criminal matters.

Result 3: Improved enabling legislative and regulatory framework for legal empowerment and access to justice.

Result 4: Enhanced integrity and transparency in the justice sector.
