### INTRODUCTION

Viet Nam has been making great efforts to achieve rapid and sustainable development with the objective of transforming the country into an industrialized and modernized country by 2020. Viet Nam is expected to access middle income status at the end of the current 10-year National Development Strategy in 2010. Project "Support to the Formulation of Socio-Economic Development Strategy (SEDS Strategy) 2011-2020" was launched in June 2008 to help to define key Viet Nam's strengths, weaknesses, opportunities and threats, and based on these, define feasible strategic development vision and goals, policy options and measures to achieve the goals hence to support the evidence, best international knowledge-based and participatory formulation of the SEDS 2011-2020. The Project is being implemented by the Development Strategy Institute, Ministry of Planning and Investment under the support of United Nations Development Programme (UNDP).

The overall objective of this project is to contribute to the formulation of the National Development Strategy (2011-2020) and realisation of the United Nations One Plan-I's Outcome 1 "Social and economic development policies, plans and laws support equitable and inclusive growth and conform to the values and goals of the Millennium Declaration and other relevant international agreements and conventions". It will directly contribute to the One Plan-I's Output 1.9 "Understanding of challenges improved and policy options identified to respond to socioeconomic impacts of globalization and integration, and more equitable distribution of the benefits from participation in international economy promoted". The project has the following outputs and groups of activities.

# I. PROJECT PERFORMANCE – CONTRIBUTION TO THE FORMULATION OF THE SEDS 2011-2020

The initial annual work plan for 2009 consisted of 22 activities with a proposed budget of USD 500,000. At the request of both the Project Management Unit (PMU) and UNDP, 5 additional activities have been added to the Quarterly Work Plans in 2009, making the total number of activities in the revised AWP being 27. Out of these 27 activities planned for 2009, 10 activities have been fully completed. 15 activities have been delayed; two activities are "on-going", i.e. they are being carried out and will be completed in 2010. The overall budget spending rate of the project is 74%.

The 1<sup>st</sup> round of bids evaluation for research papers No 1, 2, 3, 4, 5, 6, 7 and 8:

- On Tuesday 10 Feb. 2009 the Evaluation Panel met to review received EOIs and shortlist potential institutions. RFPs were then sent to them and also posted on UN/DP websites. On 29 April 2009, the Panel members met again for overall evaluation of received Technical and Financial Proposals. Three international organizations were selected to conduct the research paper No 1, 2, 3, 4, 5, 7 and 8 (No international organizations were qualified for conducting the research paper No 6). Contracts were signed with The Asia Foundation to conduct research paper No 1 (Global and regional economic development trends and their major impacts on Vietnam's economy in the next decade), research paper No 7 (Accelerating growth in agriculture productivity and rural incomes in Viet Nam: What lessons from regional experiences?) and research paper No 8 (Labour market, employment, and urbanisation in Viet Nam to 2020: Learning from international experiences). A contract was signed with the Centre for Development Policy and Research, School of Oriental and African Studies (SOAS), the University of London to conduct research paper No 3 (Competitiveness of Viet Nam's State Corporations, State-owned enterprises and private enterprises, and international experiences in promoting business competitiveness). The contracts with Harvard Kennedy school to conduct research paper No 2 (Public Investment and the Role of the State in National Development: Viet Nam and International Experiences), research paper No 4 (Viet Nam's development financing policies in the context of globalisation and international economic integration) and research paper No 5 (Industrialisation to 2020: What can Viet Nam Learn from East Asian Experiences?) are being negotiated due to the School's request for backdating the starting date of the research assignments in the contracts.

The 2<sup>nd</sup> round of bidding assessment for conducting the research paper No 6, 9, 10, 11, 16 and 17:

- On Sep. 11, 2009 Panel members met to evaluate the received Technical and Financial Proposals for conducting the research paper No 6, 9, 10, 11, 16 and 17. It was decided that no international organizations were qualified for conducting the research paper No 17. The Project is preparing the CAP documents to submit to UNDP Vietnam for approval.

# 2. Update on partnership

Coordination work in this Project had to be done at four different levels: within DSI, with the Office of the SEDS Drafting Team located at DSI, with ministries (including various departments/agencies within MPI) and with international partners.

### 2.1. Within DSI

Since the early days of the project lifetime, the Project has received strong support from different departments within DSI, especially from DSI management board, department directors/deputy directors, and its SEDS Project supporting team consisting of around 10 young and highly motivated staff members.

# 2.2. With the Office of the SEDS Drafting Team

The fact that the Office is located at DSI and its Chief is one DSI Vice President (Mr. Nguyen Ba An) facilitates a lot the daily communication between PMU and the Office, ensuring quick provision of information on needs/requirements of SEDS Drafting Team to PMU, thereby ensuring the relevance and timeliness of project activities, discussions/debates and consultations in particular, whose outputs serve as valuable inputs to the SEDS formulation process.

### 2.3. With Ministries

In 2009, the coordination with ministries was better Since this SEDS formulation exercise involves all government ministries and central agencies each of which has at least one

representative in the SEDS Drafting Team, PMU maintains close, regular contacts with these people and their representatives (since the formers are extremely busy people). Exchange of views/ideas, either officially or unofficially, contributes to the relevance and quality of project's roundtable discussions/consultation and research activities.

# 2.4. With International Partners

The partnership of the Project was built through the process of conducting the research papers. The partnership with Harvard Kennedy School has been established since early nineties and was strengthened when Harvard Kennedy School was contracted to conduct research papers No 2, 4 and 5.

The partnership with The Asia Foundation has been established since this organisation was contracted to conduct research papers No 1, 7 and 8.

The partnership with the Centre for Development Policy and Research, SOAS, the University of London has been established since this organisation has been chosen to conduct research paper No 3.

The Project has maintained and strengthened its partnership with other UN organizations such as UNICEF, UNIDO, etc. Members of PMU and DSI have been usually invited to their meetings/workshops either as participants or presenters. The National Project Manager (NPM) has been invited to make presentation on major contents of the draft SEDS 2011-2020 and related issues to representatives of UND agencies in Vietnam at UNICEF, and at UNIDO Town Hall Meeting in Hanoi. On the other hand, the Project also invites them to participate in the its discussions/debates/consultations/workshops/meetings to contribute to the SEDS 2011-2020 formulation exercise. Such exchanges have proved to be very helpful to strengthening the partnership between the Project and DSI, on the one hand, and international partners, on the other.

# II. PROJECT PERFORMANCE – IMPLEMENTATION ISSUES

## 1. UNDP Support

In general, the arrangement set between UNDP and the Project from the beginning of the Project continued to work well during the year. However, UNDP should have provided stronger support on financial issues at the Project beginning lifetime. The training courses organized by UNDP provided valuable knowledge as well as experience for Project staff.

### 2. Consultants

In 2009, the Project hired 9 international consultants and 6 national consultants (Peer Reviewers for Research Paper number 7 and Research Paper number 8)

### IV. LESSONS LEARNED

It is thought that the Project Management Unit should make sure that the 2010 work plan, once devised, is looked at as a contract with the stakeholders for the year, with the Unit held accountable for performance until the end of 2010. As demonstrated in previous years, strict adherence to work plan and a continuous drive to implement monthly deliverables would be the most effective way to manage activities.

The experience in 2009 has given the Project a few lessons that the Project should think over in devising the 2010 plan:

- o Procurement exercise (with regard to contracting research assignments) should be done in a more professional and strict compliance with UNDP rules and regulations be ensured. Since whole project team and staff did not have a chance to obtain any training in procurement before actual procurement exercise was conducted in the project, problems and some delays were unavoidable.
- o The Project needs to evolve a strategy for better integration and involvement of other concerned departments in MPI in Project activities.
- o The Project needs to recruit a National Strategic Advisor to provide advice on the key issues of the project activities to ensure that the project is on right track in supporting the formulation of Socio-Economic Development Strategy 2011-2020 and to ensure that the technical quality of the project activities satisfies the requirements of the SEDS Sub-Committee and the SEDS Drafting Team as well as conforms with the overall project designs and its annual work plans (AWPs).
- O The Project needs to recruit a Research Advisory and Review Panel to work closely with the Project staff to ensure the quality of the activities related to in-depth roundtable discussions and studies to provide the theoretical background, scientific analysis and the best international policy practices as valuable inputs to the Strategy formulation exercise its most important group of activities.
